**Opinion:**

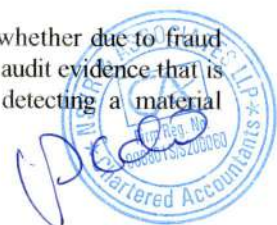

**2. Basis of preparation of financial Statements**

**Use of Estimates:**

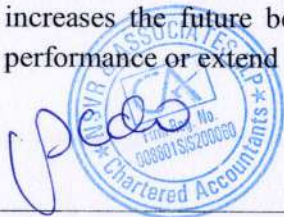

**A. Property, Plant & Equipment:**

**1. Tangible Assets**

All directly identifiable costs which are capitalised in the Previous Year were transferred to Intangible Assets as it met with the Recognition Criteria.

**B. Impairment of Assets:**

All Tangible and intangible assets are tested for impairment when there are indications that the carrying value may not be recoverable. There is no impairment loss for the year to be recognized in the statement of profit and loss.

**C. Revenue Recognition:**

Revenue is recognized upon transfer of control of promised products or services to customers in an amount that reflects the consideration which the Company expects to receive in exchange for those products or services. Revenue is measured based on the transaction price, which is the consideration, adjusted for volume discounts, credits, price concessions and incentives, if any, as specified in the contract with the customer. 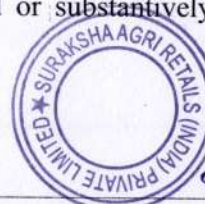
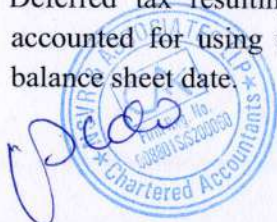
**D. Taxation:**

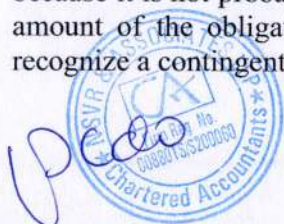


