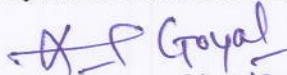

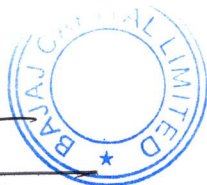

Due Diligence Process Note

We, the BRLMs, have carried out due diligence on the Company for the purposes of complying with the requirements of the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the “**SEBI ICDR Regulations**”) and other applicable laws, and to the extent that it is customary for initial public offerings of this nature in India, along with other professionals and experts engaged in connection with the Offer.

All capitalized terms used herein and not specifically defined shall have the same meanings ascribed to such terms in the draft red herring prospectus dated March 03, 2023 (“**DRHP**”).

The due diligence process carried out by us and the Legal Counsel (defined below) commenced with virtual interactions with the senior management of the Company to gain an understanding of the business of the Company, key risks involved, background of the Promoters and financial overview of the Company, amongst other matters. In this regard, we provided the Company with a due diligence questionnaire and information requisition list prepared in consultation with the Legal Counsel. In response to the due diligence questionnaire and the information requisition list, the Company provided us with supporting documents in accordance with the questionnaire for our review and diligence and gave us clarifications and explanations for our queries. In order to facilitate such review, the Company set up an online data room where copies of such relevant documents were made available for undertaking the due diligence. We have also relied on consent, certificates and undertaking from Selling Shareholder and Statutory Auditor for the information included in the DRHP relating to Selling Shareholder.

ALMT Legal has been appointed as the legal counsel to the Offer (the “**Legal Counsel**”). The Legal Counsel has assisted us in carrying out the due diligence and drafting of the DRHP in compliance with the SEBI ICDR Regulations, and advising us and the Company, as appropriate, on other legal matters, in relation to the Offer. We were also assisted by the statutory auditor of the Company, **NVSR & Associates LLP, Chartered Accountants (“Auditor”)** for the financial due diligence. In addition to the restated financial statements and providing examination report thereon, the Auditor has provided statements of possible special tax benefits available to the Company and its shareholders, has verified details and provided certifications relating to inter alia the computation of Company’s net worth, operating profit/ loss and net tangible assets to ascertain the eligibility for the Offer, compliance with corporate governance requirements, weighted average cost of acquisition of Equity Shares held by the Promoters and the Selling Shareholder for all the Equity Shares transacted in one year and three years preceding the date of the Draft Red Herring Prospectus, average cost of acquisition of the Equity Shares acquired by the Promoters and the Selling Shareholder details of the objects of the offer, the details in relation to the proposed new formulation plant of the Company and certain key performance indicators of the Company and provided various other certifications with respect to financial and other information included in the DRHP. The Statutory Auditor has also confirmed that all related party transactions have, unless otherwise disclosed in the Restated Consolidated Financial Information, been entered into in accordance with applicable laws, on an arm’s length basis. As on the date of the DRHP, the Statutory Auditor holds a valid peer review certificate issued by the peer review board of the Institute of Chartered Accountants of India). Additionally, V. Vishwanath Murthy, an independent Chartered Engineer (“**Chartered Engineer**”) also assisted the BRLMs by verifying and certifying the installed and the utilised capacity of the company in the last 3 fiscals and for a period upto January 31, 2023. The Auditor and the Chartered Engineer have each consented to be named as an expert, in terms of the Companies Act, 2013, as amended, in the DRHP and such consent has not been withdrawn as at the date of filing of this DRHP with the SEBI.

The Company has also placed a reliance on the report titled “Report on Crop Nutrition and Crop Protection Industry” commissioned and paid by the Company, issued by Care Advisory Research and Training Limited (“**Care Report**”), for disclosures in relation to industry information in the DRHP. The Care Report has been

commissioned and paid for by the Company and has been prepared exclusively for the purposes of disclosures in the “Industry Overview” section of the Offer.

1. Business and Commercial Diligence

The due diligence process in relation to general business and commercial matters included:

- (a) Organizing and attending virtual/ physical kick-off discussion to develop an understanding of the business, history and other matters of the Company and its subsidiaries, the industry overview and the regulatory environment, which were attended by certain Directors, Chief Financial Officer and members of the secretarial, legal and financial departments of the Company, certain members of the Promoter Group, our teams, the Legal Counsel and the Auditor. A broad overview of the business of the Company, the industry in which it operates, the regulatory framework with respect to the business, the corporate structure, the capital structure, financial information and shareholding pattern of the Company were presented, followed by interactive discussions.
- (b) Requesting the Company to provide all relevant documents in the data room based on the diligence requirements and requirements under applicable law, including the SEBI ICDR Regulations, and reviewing such documents along with the Legal Counsel, as is customary in such transactions.
- (c) Regularly virtually interacting with the management team of the Company, including the Key Managerial Personnel, consultants and senior personnel from the Company’s secretarial, operations, legal and finance departments and in certain cases, the Statutory Auditor for the purpose of gaining an understanding of the business, the risks involved and a financial overview of the Company, among other matters. These interactions included (i) virtual and in person due diligence meetings and calls, and conference calls to discuss the disclosures in the DRHP; (ii) due diligence calls with the Auditor; (iii) seeking appropriate clarifications and certifications from the Company for key financial, operational data and other information, including fund requirements based on the business plan of the company; (iv) bring-down due diligence calls to receive updated information from the Company before filing the DRHP; (v) seeking appropriate certification from the Company, its Directors, Key Managerial Personnel, the Company’s Promoters and Group Companies, Auditor, the Chartered Engineer among others, for certain other information; (vi) interacting with the industry consultant, namely Care Advisory Research and Training Limited, for the purposes of the Care Report used in the DRHP. Further, we received certificates from the Selling Shareholder, to prepare disclosures in the DRHP in relation to the Selling Shareholder and the Offered Shares. We expect these interactions and due diligence calls and discussions to continue until completion of the Offer. Accordingly, disclosures in respect of the business carried out by the Company as well as associated risks in relation thereto, have been made in the sections titled “Our Business” and “Risk Factors” in the DRHP.
- (d) Requesting the Company to provide documents based on the requirements under the SEBI ICDR Regulations. Assisting the Company to make available due diligence documents in a virtual data room and reviewing those documents along with the Legal Counsel, to comply with the diligence requirements as stipulated under the SEBI ICDR Regulations, and the other applicable laws, as is customary in such transactions.
- (e) Conducting diligence calls with the industry consultant, Care Advisory Research and Training Limited, appointed for commissioning the industry report for the Company.

- (f) Conducting diligence calls with the suppliers of the Company.

- (h) Undertaking a physical visit to the manufacturing units of the Company located at Singannaguda Village, Mulugu Mandal, Siddipet .
- (i) Obtaining and relying on formal representations and undertakings from the Company and the Selling Shareholder in the Offer Agreement.
- (j) Obtaining and relying on circle-ups and certificates from the Auditor on financial information, key performance indicators, financial, non-financial, operational and other business-related information and certain finance related information, including details of the amounts outstanding to small scale undertakings and other creditors of the Company, non-payment of statutory dues by the Company, compliance with corporate governance requirements by the Company, among others, as applicable, in the DRHP.
- (k) Interacting with the industry consultants, namely Care Advisory Research and Training Limited, and obtaining consents from them for including extracts of report by independent industry sources, in support of certain disclosures included in the DRHP.
- (l) For certain information, relying on management certificates from the Company for ensuring compliance with the SEBI ICDR Regulations.
- (m) Reviewed, together with the Legal Counsel, material agreements/contracts executed by, or in relation to, the Company and such other documents as we have deemed necessary and as have been provided to us by the Company, from time to time.
- (n) Scheduling and attending due diligence / bring down due diligence calls with the industry report provider to understand the sources of information provided in the industry report; and
- (o) Scheduling and attending bring down due diligence calls with the management of the Company and the Statutory Auditor of the Company.

outstanding amounts due to such creditors. For outstanding dues to any micro, small or medium enterprise, the disclosure is based on information available with the Company regarding the status of the creditor as defined under the Micro, Small and Medium Enterprises Development Act, 2006.

Pursuant to the SEBI ICDR Regulations and the Materiality Policy, for the purposes of disclosure, all pending litigation involving the Company and other Relevant Parties, other than criminal proceedings, actions by statutory or regulatory authorities and taxation matters, have been considered 'material' if: the monetary amount of the claim exceeds an amount which is 1% of the profits after tax of our Company in the most recently completed Fiscal i.e. Financial Year 2022, as per the Restated Financial Information i.e. 1% of ₹ 1368.93 lakhs amounting to ₹ 13.68 lakhs ; or all other outstanding litigation which may not meet the specific threshold and parameters as set out in above, but where an adverse outcome would materially and adversely affect the business, operations, performance, prospects, financial position or reputation of the Company. Disciplinary action including penalty imposed by the SEBI or stock exchanges against the Promoter in the last five Fiscals, including outstanding action, if any, have also been considered. All pending litigation involving the Individual Promoters and Directors, the outcome of which could have a material adverse effect on the business, operations, performance, prospects, financial position or reputation of our Company, irrespective of the amount involved in such litigation, have been considered for the purposes of disclosure.

Pre-litigation notices received by the Company, its Directors, its Subsidiaries or its Promoters from third parties (excluding those notices issued by statutory/regulatory/ governmental/ tax authorities) have not been, unless otherwise decided by the Board of Directors, considered as an outstanding litigation for the purposes of points above, until such time such party is impleaded as a defendant or respondent in litigations before any legal/arbitral forum.

The Company has provided a consolidated statement along with the relevant supporting documents for material civil cases, all outstanding criminal proceedings involving the Company, actions by statutory / regulatory authorities, and taxation matters involving the Company.

For disclosures relating to litigation involving the Directors and Promoter, the Company has provided certifications received from such relevant parties.

Based on the SEBI ICDR Regulations and the Materiality Policy, disclosures on dues to material creditors have been provided in summary format (indicating the total number of, and aggregate outstanding amounts due to such creditors). Pursuant to the Materiality Policy, for the purposes of disclosures in the DRHP, outstanding dues to any creditor of the Company that equal to or in excess of 5% of the trade payables of our Company as of the end of the most recent period covered in the Restated Financial Information, have been considered material. Accordingly, in the DRHP, creditors of the Company to whom an amount equal to or exceeding 5% (being ₹ 161.21 lakhs) of the trade payables as discussed above, for the period ended 30th September, 2022 was owed, were considered 'material' creditors.
